PROCEDURE FOR ISSUING PASSPORT

Society

- 1. Enter the name of the horse on the cover page and ID page
- 2. Enter the date and issue by the Society on page headed 'Details of Owner/Lessee'
- 3. Issue owner/lessee with passport
- 4. On return of completed passport, the Society must check as far as possible that all entries are fully and accurately completed and then take the following action
 - a. 'Details of Owner/Lessee': stamp and sign where indicated
 - b. 'Description and Outline Diagram': stamp and sign where indicated
- 5. Photocopy cover page, detail or ownership page and description page
- 6. Return passport to Owner/Lessee

Owner/Lessee - Receives named, numbered, dated but otherwise blank passport from Society

- 1. Complete page 'Details of Owner/Lessee' with the exception of the date column and column for the stamp of the Society
- 2. Request own veterinarian to complete the 'Description and Outline Diagram' page and relevant 'Vaccination Record'
- 3. Ensure the Equine Influenza and African Horse Sickness vaccinations are kept up to date
- 4. Return completed passport to Society for validation.

Veterinarian

- 1. Complete 'Description' year of birth, sex, colour, country of birth and breeding details (where known obtain details from owner) in **black block capitals**. No line should be left blank
- 2. Complete 'Outline Diagram' using a red ball point pen to outline white markings without shading but lightly hatched if desired. And black ball point pen to indicate whorls and other markings. Particular attention should be paid to whorls, shown with an 'X' on the head (universal), neck (universal) and jugular region (common) and to rear view of fore and hind legs. A Permanent scar is indicated by an arrow pointing to the site. Acquired marks such as tattoos and brands are indicated by a sketch. A de-pigmented area on a hoof (especially common in grey horses) is indicated by a sketch and coloured red. Finally, date, stamp and sign where indicated, thereby authenticating the identity of the horse
- Complete relevant 'Vaccination Record'. Primary Equine Influenza vaccination (no less than 21 days and no more than 92 days apart) must be entered in addition to annual (less than 6 months) boosters as well as African Horse Sickness inoculations.
- 4. Complete 'Laboratory Health Tests' when such tests are performed. Entries must be certified with the veterinarian's signature

No alterations to any error/incorrect entries in the passport are permitted. Any such errors/incorrect entries must be clearly deleted and a new entry made and signed by the Society Please ensure that all entries in the passport are accurate and complete

Details of Ownership

- 1. The nationality of the horse is that of the owner
- 2. Request own veterinarian to complete the 'Description and Outline Diagram' page and relevant 'Vaccination Record'
- 3. If there is more than one owner or the horse is owned by a company, then the name of the individual responsible for the horse shall be entered in the passport with his nationality: if the owners are of different nationalities, they have to determine the nationality of the horse

COMPULSORY INOCULATIONS

African Horse Sickness

- 1. All inoculations against African Horse Sickness must be administered by a Registered Veterinarian who must fully record the vaccination in the horse's passport and sign in the relevant place
- 2. The vaccine is live and must be cared for in accordance with the manufacturers instructions otherwise it will lose its effectiveness. The inoculations must be given annually and there must be an interval of at least 21 days between the first and second inoculations
- 3. Owners of horses domicile in the African Horse Sickness Free Zone should contact the Society for details of the regulations applicable to that area

Equine Influenza

- 1. It is compulsory for all horses to be inoculated against Equine Influenza in accordance with the manufacturer's instructions at intervals not exceeding six months, by a Registered Veterinarian
- 2. The date and batch number of the inoculation must be entered in the horse's passport and must be signed by the person administering the inoculation
- 3. Failure to Inoculate within the specific six months entails repeating the Primary and Secondary inoculations
